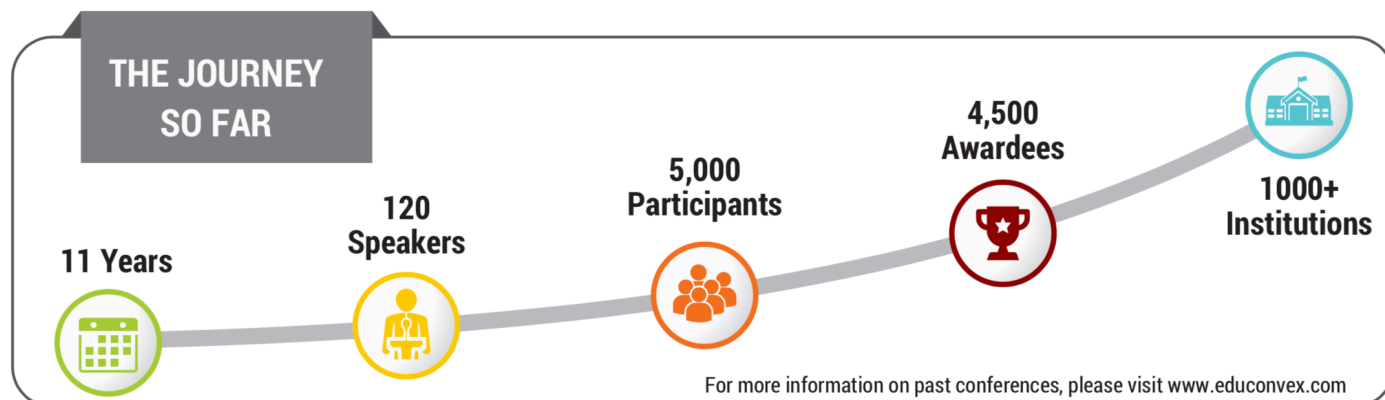

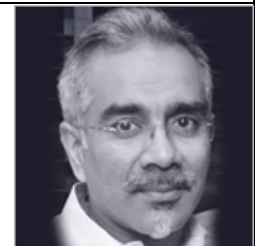
Mr. Sanjay Malaviya, Managing Trustee, The Future Foundation
